Additional information	In two GLP-study according to OECD test guideline 414 (rats and rabbits), the registered substance, orally applied, did not reveal any adverse effects on the pregnancy, body weight, food consumption data of the dams/does and on the intrauterine development of the fetuses. Therefore, the NOAELs for maternal toxicity and the NOAELs for developmental toxicity were 1000mg/kg bw/day. This result is supported by the absence of adverse effects in an oral reproductive/developmental screening study (OECD TG 421, GLP-compliant) with a close structural analogue, in which no adverse effects (parental, fertility and offspring) were observed up to 1000 mg/kg bw. In an oral reproductive/developmental screening study (OECD TG 421, GLP-compliant) with a close structural analogue, no effects on fertility were observed up to 1000 mg/kg bw, most likely due to the fact that the substance is not bioavailable.
