Furthermore, there was no embryo-toxicity and no effect on the developing fetuses. No malformations or variations were noted during (i) the macroscopic inspection at laparotomy (including an external inspection and gross inspection of the organs), (ii) the skeletal examination according to Dawson and (iii) the soft tissue examination according to Wilson.
